diversity, which has improved also my communication and intercultural skills. For more than 20 years I am involved in the developing concepts, regulation and funding of minority and immigrant cultures in Slovenia with the Ministry of Culture of the Republic of Slovenia. This work incorporates also communication with representatives of diverse minority and immigrant communities and their associations.

Organizational skills and competences: I have been working in diverse associations and organizations and, among others, I was leading (1982-1986 and 1988-1989) the UN Clubs of Slovenia, a NGO with more than 10.000 members and 600 clubs in primary and secondary schools and townships. I have organized several summer schools and camps (especially in the1980s and 1990s), seminars, workshops, conferences and congresses. In the time of transition and democratization (in the 1980s and early 1990s) I was also politically active in democratization activities.

<u>Managing skills and competences:</u> Between 1993 and 1997 I was a president of the Board of the IES, and in the period 1998-2007 I was the director of the IES. Since I became the director the Institute grew from 24 to 31 employees, of them 24 researchers; initially there were 3 researchers with Ph.D., while in 2007 there were 19 researchers with Ph.D.

An important activity that contributes to education and training of young researchers and academics and to the development of ethnic studies in Slovenia and broader (cooperation of Australian and other partners) is the Students' Research Project (that involves undergraduate and post-graduate students from different faculties of the University of Liubliana) that I am coordinating since 1994.

I have established, developed and coordinated several higher education (undergraduate and (post) graduate) courses and programs. Since 1996, I am coordinating the MA Program in Political Science – Ethnic Studies at the Faculty of Social Sciences that I established and developed. Based on this program, MA program Ethnic Studies (Bologna II) was developed that I coordinate and that received its Bologna accreditation (in 2005; re-acredited in 2015). I also coordinate Ph.D. Program in Diversity Management (and Governance) at the University of Primorska.
